The City of Frisco is striving to meet the practice demands for all sports organizations. In addition to Frisco neighborhood park sites, the Parks & Recreation Department has a partnership with the Frisco ISD to utilize non-irrigated elementary school sites for practice. In order to create synergy and consistency, the following properties can be utilized by Frisco-based teams for practice needs. The Frisco Parks & Recreation Department does not reserve specific practice spots for these locations. Instead, these locations have been assigned to the youth athletic league partners to manage and assign specific teams. The City of Frisco cannot authorize practice on private property such as churches, HOA properties, etc.
