### DEED NOTICE FOR INDUSTRIAL SOLID WASTE DISPOSAL SITE

Pursuant to the rules of the Texas Commission on Environmental Quality ("TCEQ") pertaining to industrial solid waste management, this document is hereby filed in the deed records of Collin County, Texas in compliance with the notice requirements of 30 Tex. Admin. Code § 335.5.

Exide Technologies is permanently depositing Class 2 industrial solid waste and corrective action management unit-eligible waste designated in Texas Commission on Environmental Quality (TCEQ) Agreed Order No. 2013-2207-IHW-E (CAMU Waste), as detailed on Exhibit A attached hereto and made a part hereof, in a waste unit located on the land described on Exhibit B attached hereto and made a part hereof. Exhibit A provides a copy of the Notice of Registration pages for Solid Waste Registration No. 30516 and an excerpt from Agreed Order No. 2013-2207-IHW-E, identifying the unit and wastes left in place. Exhibit B, provides the metes-and-bounds description of the tract where Class 2 industrial solid waste and CAMU Waste has been or will be left in place and a plat map clearly demarcating the portion of property that contains the waste unit.

Wastes deposited or to be deposited on the above-described property have been classified as Class 2 Industrial Solid Waste, in accordance with the waste classification requirements contained in 30 Tex. Admin. Code §§ 335.501-335.515, or CAMU Waste in accordance with the terms of the above-referenced TCEQ Agreed Order. The CAMU Waste consists of treated slag waste classified as Class 2 Industrial Solid Waste or as hazardous waste with U.S. Environmental Protection Agency waste codes D006 and D008 previously deposited in the CAMU as well as additional Class 2 Industrial Solid Waste to be deposited in the CAMU prior to closure of the unit.





Excerpt of Texas Commission on Environmental Quality (TCEQ) Agreed Order No. 2013-2207-IHW-E - Section I, Paragraph 25.

25. The following wastes are CAMU-eligible wastes that are authorized to be contained in the Class 2 landfill: the treated slag that currently exists in cells 1 through 12, waste in the Treated Slag Piles that meets Class 2 specifications, the re-treated slag that is currently contained in nine roll-off boxes located within the footprint of the Class 2 landfill at the Facility, and the Class 2 non-hazardous remediation waste associated with clean-up activities for VCP No. 2541 (J Parcel) and other Class 2 remediation waste approved in the Final Closure Plan.


### **EXHIBIT B**

### **LEGAL DESCRIPTION**

Being 8.247 acres of land located in the L. H. McNEIL SURVEY, Abstract No. 618, City of Frisco, Collin County, Texas, and being a portion of the tract of land designated as Tract One in the deed to GNB Batteries, Inc., recorded in Volume 1769, Page 299, of the Deed Records of Collin County, Texas. Said 8.247 acres of land being more particularly described by metes and bounds as follows:

COMMENCING at a point in the East boundary line of said Tract One to GNB Batteries, lying at the intersection of the centerline of Eubanks Street (a private ingress/egress easement) and the West right-of-way line of 5<sup>th</sup> Street, and said POINT OF BEGINNING also being the Southeast corner of the tract of land designated as Save and Except Tract One in the aforesaid deed to GNB Batteries. Said Save and Except Tract also being the same tract of land conveyed to Dorothy Rolater, by the deed recorded in Volume 1599, Page 937, of the Deed Records of Collin County, Texas;

- THENCE S 63° 24' 34" W 361.86 feet, to a ½" iron rod marked "Brittain & Crawford" set, at the POINT OF BEGINNING having Texas State Grid Coordinates N: 7,103,684.12 and E: 2,480,741.93;
- THENCE SOUTHEASTERLY 123.54 feet, along a curve to the right, having a radius of 80.00 feet, a central angle of 88° 28′ 48″, and a chord bearing S 33° 24′ 04″ E 111.63 feet, to a ½″ iron rod marked "Brittain & Crawford" set, at the end of said curve;
- THENCE S 11° 33' 04" W 498.15 feet, to a ½" iron rod marked "Brittain & Crawford" set, at the beginning of a curve to the right;
- THENCE SOUTHWESTERLY 123.56 feet, along said curve to the right, having a radius of 80.00 feet, a central angle of 88° 29' 45", and a chord bearing S 56° 30' 43" W 111.64 feet, to a ½" iron rod marked "Brittain & Crawford" set, at the end of said curve;
- THENCE N 78° 31' 52" W 397.06 feet, to a ½" iron rod marked "Brittain & Crawford" set, at the beginning of a curve to the right;
- THENCE NORTHWESTERLY 123.71 feet, along said curve to the right, having a radius of 80.00 feet, a central angle of 88° 35′ 54″, and a chord bearing N 33° 31′ 15″ W 111.74 feet, to a ½″ iron rod marked "Brittain & Crawford" set, to a point at the end of said curve;
- THENCE N 11° 29' 19" E 499.42 feet, to a ½" iron rod marked "Brittain & Crawford" set, at the beginning of a curve to the right;
- THENCE NORTHEASTERLY 123.91 feet, along said curve to the right, having a radius of 80.00 feet, a central angle of 88° 44′ 37″, and a chord bearing N 56° 34′ 17″ E 111.89 feet, to a ½″ iron rod marked "Brittain & Crawford" set, at the end of said curve;
- THENCE S 78° 20' 48" E 397.60 feet, to the POINT OF BEGINNING containing 8.247 acres (359,242 square feet) of land.
