No, the center is staffed and operated by Premise Health. It is managed just like any other licensed medical office in the community.

## What type of medical staff will work at the center?

# Can my medical records be shared between the center and my primary care provider (PCP)?

You can request that your PCP share your records with Frisco Employee Wellness Center by completing your provider's record sharing process. Additionally, you may request for Premise Health to share your records with your PCP or specialist.
