## AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FRISCO, TEXAS, DECLARING AS ELECTED THE UNOPPOSED CANDIDATES FOR THE OFFICES OF PLACE NO. 2 AND PLACE NO. 4 OF THE FRISCO CITY COUNCIL IN THE MAY 7, 2022, GENERAL ELECTION; CANCELLING THE ELECTION; AND PROVIDING A SAVINGS/REPEALING CLAUSE, SEVERABILITY CLAUSE AND AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Frisco, Texas ("<u>City Council</u>") ordered a general election to be held within the City of Frisco, Collin and Denton Counties, Texas ("<u>Frisco</u>"), on May 7, 2022, for the purpose of electing two members of the Frisco City Council (Place Nos. 2 and 4), with each such term being for a period of three years; and

WHEREAS, the City Secretary has certified in writing that each candidate on the ballot is unopposed for election to office and that no person has made a declaration of write-in candidacy, as set forth in the certification attached hereto as <u>Exhibit A</u>; and

WHEREAS, under these circumstances, Section 2.053 of the Texas Election Code authorizes the City Council to declare the candidates elected to office and cancel the election.

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FRISCO, TEXAS:

<u>SECTION 1</u>: <u>Findings Incorporated</u>. The findings set forth above are incorporated into the body of this Ordinance as if fully set forth herein.

<u>SECTION 2</u>: <u>Unopposed Candidates Declared Elected</u>. The following candidates, who are unopposed in the May 7, 2022, General Election, are declared elected to office, and shall be issued certificates of election following the time the election would have been canvassed:

Tammy Meinershagen, Council Member, Place No. 2 Bill Woodard, Council Member, Place No. 4

<u>SECTION 3</u>: <u>General Election Cancelled</u>. The May 7, 2022, general election is cancelled. The City Secretary is directed to cause a completed copy of the notice attached hereto as <u>Exhibit</u> <u>B</u> to be posted on Election Day at each polling place that would have been used in the election and to advise the Collin County Elections Administrator and the Denton County Elections Administrator of the same.

<u>SECTION 4</u>: <u>Severability</u>. Should any section, subsection, sentence, clause or phrase of this Ordinance be declared unconstitutional and/or invalid by a court of competent jurisdiction, it is expressly provided that any and all remaining portions of this Ordinance shall remain in full force and effect. The City Council hereby declares that it would have passed this Ordinance, and each section, subsection, clause and phrase thereof regardless of whether any one or more sections,

subsections, sentences, clauses or phrases may be declared unconstitutional and/or invalid.

<u>SECTION 5</u>: <u>Savings/Repealing</u>. All provisions of any ordinance in conflict with this Ordinance are hereby repealed to the extent they are in conflict. Any remaining portion of conflicting ordinances shall remain in full force and effect.

<u>SECTION 6</u>: <u>Effective Date</u>. This order for an election becomes effective immediately upon its passage.
