Dear Mr. Lall:

Southwest Geoscience (SWG) appreciates the opportunity to submit this request for an extension to the February 7, 2014 response deadline for the above-referenced Voluntary Cleanup Program (VCP) site located off Eagan Way, in Frisco, Texas (the "Site".)

Based on the Texas Commission on Environmental Quality (TCEQ) comments in the above-referenced letter, additional evaluation of the Stewart Creek area in the vicinity of the Site will be required. In addition, TCEQ has requested extensive evaluations of Stewart Creek from Exide and the City related to various ongoing Exide investigation and City VCP projects. City representatives recently met with TCEQ representatives to request a coordinated TCEQ approach to Stewart Creek investigation and remediation. That request is now under consideration by TCEQ executive staff.

Due to this coordination request, the City of Frisco is hereby requesting an extension on the response deadline for the Former SCWWTP of 180 days.

In regard to the suspected municipal solid waste that was discovered at the SCWWTP site, the City is reviewing regulatory options to address this issue. For clarification, this is the area on the south side of the site, not the northeast corner of the South Area excavation where incidental treatment plant waste was discovered. That waste was managed as part of the general site remedial activities. Further information will be provided to the TCEQ to address the suspected municipal solid waste disposal area in future correspondence.

Due to this request for a 180-day extension, the City of Frisco also requests a temporary suspension of the submittal of the monthly status reports (MSRs)

pending a decision by the Executive Director on how the overall Stewart Creek contamination will be addressed.

If the modified deadline is acceptable to the TCEQ, please return a written response confirming the extension for our records. If you should have any questions or comments regarding this correspondence, please contact the undersigned at 214-350-5469.
