The Texas Commission on Environmental Quality (TCEQ) has reviewed the April 10, 2015 Affected Property Assessment Report (APAR) for Partial Response Action Area 2 (PRAA-2). Please note the following comments:

- 1. Soil Assessment: The TCEQ concurs that the APAR demonstrates that soil assessment is complete. Chemicals of concern (COCs) were detected in shallow soil at three sample locations above the critical protective concentration level (PCL). As indicated in the APAR, a Response Action Plan (RAP) will be required to address soil affected above the critical PCL.
- 2. Groundwater Assessment: One monitoring well was installed on PRAA-2. The monitoring well was dry when it was installed in November 2014 and remained dry when last gauged in February 2015. The detected concentrations of COCs in a groundwater sample from well GP-MW-15, which is located adjacent to PRAA-2, are below residential PCLs. The TCEQ concurs that the groundwater assessment is complete at this PRAA and no response action for groundwater is required.
- **2. Tier 1 Exclusion Criteria Checklist**: The TCEQ concurs with the conclusion made in the Supporting Documentation that this site meets the exclusion criteria for ecological risk assessment.
