Dear Mr. Purefoy:

The VCP of the Texas Commission on Environmental Quality (TCEQ) has reviewed the above referenced document entitled *Request to Modify Waste Characterization Procedures*. Exide proposes to use site investigation and characterization samples for waste characterization and disposal purposes. Exide indicates that this modification will decrease the potential for air emissions and stockpiling issues because it will eliminate the need for repetitive soil handling related to excavation, stockpiling while holding for additional sampling results and loading waste. Pre-characterized Class 2 contaminated soil would be excavated and taken directly to the Class II Corrective Action Management Unit (CAMU). Areas where soil has been deemed hazardous would be transported to an off-site disposal facility. The TCEQ approves the requested modification. Please note that post-excavation confirmation sampling of soils to demonstrate that all soil containing contamination above the critical Protective Concentration Levels (PCLs) has been removed will still be required. In addition, this approval for precharacterization of waste applies only to this specific conditions on the UBP and may not be appropriate elsewhere.
