

FIREFIGHTER / EMT- PARAMEDIC City of Frisco Fire Department

Under general supervision of a Fire Officer, performs journey level Firefighter / EMT-Paramedic duties including fire suppression, emergency medical services, rescue, hazardous materials incidents, fire prevention and fire inspections. Supervises and controls emergency medical scenes until relieved by a higher ranking paramedic officer.

- Responds to emergency medical, motor vehicle accidents and injured person calls utilizing a Mobile Intensive Care Unit (MICU)
- Acts as commanding medical officer in absence of higher ranking paramedic officer.
- Secures safety of medical scene and determines medical status and priority of medical treatment
- Performs emergency medical care and treatment according to established medical protocol and standard operating procedures
- Stabilizes and immobilizes patients and prescribes mode of transportation to emergency medical care facilities based on condition of patients
- Maintains inventory of medical supplies and equipment for assigned station and Mobile Intensive Care Unit
- Follows established universal health precautions in the treatment and care of patients
- Inspects, tests, cleans and maintains station facilities, property, fire suppression equipment, emergency medical apparatus and vehicles
- Responds to emergency fire calls for fire suppression and extinguishment
- Participates in daily training exercises and instruction to increase performance
- Conducts hydrant testing including the inspection of flow pressure and proper working condition
- Conducts inspections of businesses to identify possible fire hazards and educate business owners in fire prevention
- Maintains all activity and material usage logs
- Knowledge of Federal, State and City Fire Codes and ordinances
- Knowledge of fire prevention, suppression, and education methods, practices and procedures for a variety of fire, hazardous materials responses, emergency management systems, emergency Paramedic services and rescue operations
- Knowledge of emergency advanced life support methods, techniques, practices and procedures including resuscitation, CPR, heart monitors, intubation equipment, airway suction, and defibrillation

- Knowledge of established medical protocol and standard operating procedures related to medical response and treatment practices and procedures
- Knowledge of computers and related equipment, hardware and software for development and tracking of safety and health inspections, annual reviews, and noncompliance issues
- Knowledge of City policies and procedures
- Skill in effective oral and written communications
- Skill in responding to emergency fire suppression, vehicular and other types of accidents and rescue operations
- Skill in safely securing emergency medical scenes, assessing medical status and prescribing medical treatment of patients
- Skill in appropriately responding to emergencies and conditions
- Skill in stabilizing, immobilizing and transporting medical patients
- Skill in implementing assigned Fire Station procedures and objectives
- Skill in resolving customer complaints and concerns
- High School Diploma or G.E.D.
- Must possess Basic Firefighter Certification with the Texas Commission on Fire Protection
- Must possess EMT-P Certification issued by the Texas Department of Health
- Must maintain all requirements for continuing certifications
- Must pass a pre-employment drug screening and post-offer physical exam
- Must possess State of Texas Class B exempt Drivers License
