



FOOD ESTABLISHMENT PERMIT TYPE INFORMATION

Type of Business	Description	Annual Fee
Restaurant (Annual)	An establishment that prepares, sells and serves TCS and non TCS foods on premises, take out or delivery to the general public.	\$500
Convenience (Annual)	An establishment that sells TCS and non TCS food items such as prepackaged and candy and may have a selection of basic non-food items. (e.g.CVS, Walgreens)	\$250
Daycare (Annual)	A facility that is required by any regulatory agency to be inspected by the local regulatory authority that prepares and serves TCS and non TCS foods.	\$300
Grocery (Annual)	A retail food establishment that provides grocery/food items and retail items to the general public. Grocery stores contain one or more departments.	\$300+
Mobile Food Unit-Cold (Annual)	A mobile food unit that moves from point of sale to point of sale, not stationary in any location for greater than fifteen (15) minutes. A mobile food unit without a kitchen on the vehicle or a pushcart.	\$300
Mobile Food Unit- Hot (Annual)	A mobile food unit that moves from point of sale to point of sale, not stationary in any location for greater than fifteen (15) minutes. A mobile food unit with kitchen on the vehicle.	\$400
Temporary (up to 14 days)	A vendor that operates in conjunction with events less than 15 days such as carnivals, parades, grand opening *Applications will not be accepted if received within 3 business days of the event	\$50
Short Term Merchant (Annual)	Person or persons that prepares, serves, or otherwise provides food for human consumption directly to the consumer at designated locations, such as, farmers' market and operate(s) for more than 14 consecutive days.	\$100
Concession (Annual)	A food establishment operating on an annual basis for the purpose of providing food at sporting events associated with an Independent School District, university, community college, non-profit organization, privately owned school, or the City of Frisco.	\$50
Limited Food Establishment (Annual)	An operation that is required by any regulatory agency to be inspected by the local regulatory agency, but which does not meet the definition of a Food Establishment, as amended. (e.g. Foster Care and Daycares serving only non TCS foods or no food)	\$100
Stationary Food Vendor (Annual)	Any person who operates or sells food from a stationary cart, or trailer-mounted on a chassis, but without an engine, from period of fifteen (15) days or greater per year.	\$400

Food Truck (Annual)	A vehicle-mounted, self-contained food service operation, designed to be readily moveable (including catering trucks) and used to store, prepare, display, serve or sell food. Food Trucks must completely retain their mobility at all times and is permitted to operate at approved locations for a period of time exceeding fifteen (15) minutes.	\$400
Seasonal Food Establishment (up to 30 days)	A food establishment that operates at a fixed location for a period greater than fourteen (14) consecutive days, but less than thirty (30) consecutive days in conjunction with a single event or celebration *Applications will not be accepted if received within 3 business days of the event.	\$100
Cafeteria (Annual)	An establishment that sells and provides food via self-service or counter service.	\$500
Catering (Annual)	Food service prepared at an approved and permitted location but delivered to another	\$500
Central Preparation Facility (Annual)	Central preparation facility--An approved and permitted facility or space where food is prepared, stored, and packaged and wrapped. Use of a private residence as a central preparation facility is prohibited. Central preparation facility provides the following for Mobile Food Unit: <ul style="list-style-type: none"> a. Supply fresh water and ice; b. Wastewater disposal system; c. Facility for cleaning, including washing, rinsing, and sanitizing of food-contact surfaces or items not capable of being immersed in the Mobile Food Unit utensil-washing sink. d. Food storage and preparation 	\$500
Kiosk (Annual)	A free standing booth or stand (not in line with the perimeter) of a mall that prepares and sells TCS and non TCS foods	\$200
Private (Annual)	An establishment that prepares, serves and sells or provides food to members, guests, students, or residents of a Hotel, Fitness Center, Academy, Conference Center, Country Club, Assisted Living/Senior Living facility.	\$500
School/City (Annual)	A facility owned or operated by a school district or the City	\$0
Stadium Concession (Annual)	An establishment that sells both TCS and non TCS foods at a stadium athletic and entertainment event. Includes Stars Center, Roughriders Ballpark, FC Dallas	\$200
Stadium Kiosk (Annual)	A free standing booth or stand that sells both TCS and non TCS foods at a stadium athletic and entertainment event.	\$200
Stadium Restaurant (Annual)	An establishment that prepares (cooks or reheats using oven, grill, or fryer), sells and serves TCS and non TCS foods at an athletic or entertainment event. Includes Stars Center, Roughriders Ballpark, FC Dallas	\$400
